Mr. Yip has delivered talks on mediation to the Chartered Institute of Housing, Asian Pacific Branch and City University of Hong Kong, the Law Reform Commission of the Macau Special Administrative Region, Town Planning Department, Hospital Authority, Joint Mediation Helpline Office Limited, United Christian Hospital and the Hong Kong Association of Property Management Companies.
